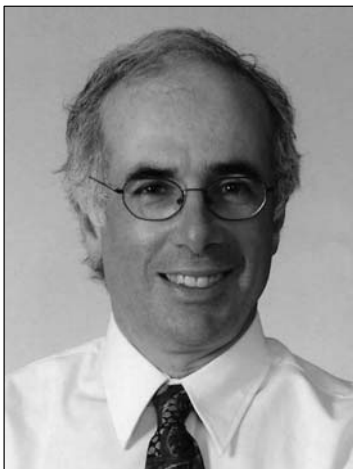

Martin F. Shapiro, MD, PhD was Professor of Medicine and Health Services and Management and Chief of the Division of General Internal Medicine and Health Services Research at UCLA from 1991 to 2016. During this tenure of 26 years, he built one of the largest, most diverse and most successful divisions of General Internal Medicine in the country. Dr. Shapiro set the warm, nurturing tenor of the Division, which contained a content, consistent, thriving faculty of clinician investigators and PhD social scientists who collaborate in research and training. The Division developed robust programs in patient care, in clinical and research training, and in research.

Dr. Shapiro received his undergraduate and medical degrees from McGill. He completed his residency training at Royal Victoria Hospital in Montreal and UCLA. He was a Robert Wood Johnson Clinical Scholar and completed a Masters in Public Health and a PhD in History from UCLA. In 1978, he published *Getting Doctored: Critical Reflections on Becoming a Physician*, a critical memoir that explores the process whereby young medical students are transformed, seemingly overnight, into hardened, alienated "professionals." From the outset, Dr. Shapiro's scholarship focused on assuring that medical care is applied equitably and appropriately to the population. He has performed research that advanced the field in the areas of access to care, cost, quality and outcomes of care, disparities in health and health services, scientific misconduct, pharmaceutical advertising, and behavioral strategies in management of chronic diseases.

Dr. Shapiro was the Principal Investigator of the HIV Cost and Services Utilization Study (HCSUS). He led a national team at over 20 institutions in evaluating such issues as diffusion of antiretroviral therapy, access, costs, outcomes of care, health status, mental illness, and disparities in and barriers to receipt of care in the first nationally representative study of healthcare for persons with HIV. He established UCLA's Primary Care NRSA Research Fellowship. Dr. Shapiro is an elected member of the American Society for Clinical Investigation and the Association of American Physicians, and is a past President of the Society of General Internal Medicine.

While Dr. Shapiro cared dearly about equity and fairness in allocation of healthcare resources and focused on rigor in research, more than anything else, Dr. Shapiro is a deeply caring physician to his patients and a dedicated mentor to his colleagues. He flew a patient 10,000 miles to get him home to die. He is the first to recognize unmet need in a clinical setting and to decipher the hidden diagnosis by asking the right question or identifying the subtle physical finding. Dr. Shapiro set the tone for doing the right thing and was always available to mentor and consult. He met with fellows at midnight to rehearse their SGIM meeting presentations. He was always selfless in his support of his mentees and faculty.

Dr. Shapiro inspired and taught, mentored and doctored. As a researcher and as a physician, Dr. Shapiro was the role model in General Internal Medicine at UCLA.
