### Project: Partnership between UCLA Health and R&F Properties



#### **Background**

On Nov. 2<sup>nd</sup> 2016, UCLA Health signed an agreement to advise R & F Properties in the development of a new, state-of-the-art, Western-style hospital in Guangzhou, China. This project focuses on bringing clinical excellence, superb patient experience, technology, and access to the region.

The agreement between UCLA Health and R&F Properties, one of the leading property developers in mainland China, was signed in Guangzhou in a ceremony attended by Chinese and U.S. dignitaries, including U.S. Ambassador Max Baucus and Consul General Charles Bennett, and R&F Properties Chairman Zhang Li and Senior Vice President Simon Zhuang.

#### **Highlights of Partnership**

UCLA Health will serve as an international consultant for the development of a new Western-style hospital and health system in China. The hospital is independently owned and operated by R&F Properties.

- Agreement marks UCLA Health's first significant venture into international hospital consulting that engages faculty and staff.
- With a planned ground area of 40,000 square meters, the hospital aims to provide world-class medical service to the region by operating in accordance with the standards of the Joint Commission International (JCI).
- The Western-style hospital will be a first for Guangzhou, which is one of the largest cities in China.
