DESCRIPTION

Fellows will participate in the inpatient palliative care consult service at GLA VA. The primary clinical responsibility of the trainee during this rotation will be to see new and follow-up inpatient referrals daily under supervision of the palliative care attending physician and in collaboration with the interdisciplinary team. The members of the inpatient palliative care team are the attending physician, social worker, palliative medicine fellow, chaplain, RN and Internal Medicine resident. The inpatient team may be consulted for a variety of different issues including (not limited to) pain and symptom management, decision-making, goals of care, and inpatient and outpatient hospice referrals.

On this rotation you will participate in, or may lead, a family goals of care discussion. If you do lead a family goals of care discussion, your attending and members of the interdisciplinary team will join the meeting to support you. After leading a family meeting PLEASE NOTIFY JENNIFER AYALA WHICH ATTENDING WAS PRESENT SO THAT AN EVALUATION FORM (Mini CEX) MAY BE COMPLETED BY YOUR ATTENDING. In order for your attending to fill out a Mini CEX form, the family meeting must be directly observed by your attending.
