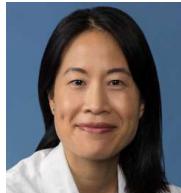
Meet the faculty



Jamil Aboulhosn, M.D.

*Director, Ahmanson/UCLA Adult Congenital Heart Disease Center
Streisand Chair in Cardiology*

Dr. Aboulhosn, a distinguished physician-scientist, specializes in adult congenital heart disease (ACHD), structural interventional cardiology and heart disease in pregnancy. He completed his medical degree, residency, and fellowships in cardiovascular disease and ACHD at UCLA. Dr. Aboulhosn is a member of the writing committee for the American College of Cardiology/American Heart Association Guidelines on Adult Congenital Heart Disease and is the chairman of the American Board of Internal Medicine ACHD Board Examination Committee. He is also actively involved with Camp del Corazon, a free camp for children with heart disease. While Dr. Aboulhosn is a decorated international leader in adult congenital heart disease, he recognizes the importance of treating each patient as a unique individual, providing compassionate care to each person he sees.

**Jeannette Lin, M.D.**

Director, Adult Congenital

Professor, Medicine

Dr. Lin received her medical degree from the University of California, San Diego, and completed her residency at UC San Diego, cardiology fellowship at the University of California, Irvine, and ACHD fellowship at UCLA. She has been a faculty member at the Ahmanson/UCLA Adult Congenital Heart Disease Center since 2012. Dr. Lin provides care for ACHD patients, with a special focus on echocardiography. As the director of the UCLA Adult Congenital Heart Disease Fellowship, she oversees all aspects of medical education for the center. In addition, she is co-director of the Cardio-Obstetrics Program at UCLA.

**Leigh Reardon, M.D.**

Professor, Clinical Medicine and Pediatrics

Dr. Reardon's practice is in pediatric cardiology and adult congenital heart disease. He received his medical degree at the University of Virginia, and he completed his residency at Cedars-Sinai Medical Center and fellowships in pediatric cardiology and ACHD at UCLA. Dr. Reardon has a specific interest in heart failure, transplantation, mechanical support, and the care of adolescents and young adults as they transition from the pediatric to the adult clinical setting.

**Gentian Lluri, M.D., Ph.D.**

Dr. Lluri received his M.D. and Ph.D. degrees from the University of Vermont. He completed his residency at the University of Illinois Chicago and fellowship training in cardiovascular disease as well as ACHD training at UCLA, joining the faculty shortly thereafter. Dr. Lluri's clinical and research goals are to improve the lives and advance the care of patients with congenital heart disease.

**Jeremy P. Moore, M.D., M.S.**

Dr. Moore is a congenital electrophysiologist and has been a member of the UCLA faculty since 2010. He received his medical degree from the VCU College of Health Professions and completed his residency and fellowship in pediatric cardiology at UCLA. Dr. Moore then went to Vanderbilt University to gain subspecialty expertise in pediatric electrophysiology. He is board certified in pediatrics, pediatric cardiology, adult congenital heart disease and electrophysiology. He is also a board-certified cardiac device specialist. Dr. Moore cares for patients with congenital and acquired disorders of cardiac rhythm, with a special emphasis on the management of complex rhythm disorders in adults with congenital heart disease. He is a fellow of the American College of Cardiology and the Heart Rhythm Society. He serves as section editor for the *Journal of American College of Cardiology* and *JACC Clinical Electrophysiology*. Dr. Moore is also co-chair of the Pediatric and Congenital Electrophysiology Society/International Society for Adult Congenital Heart Disease Electrophysiology Research Consortium.

About the board

Primary objectives

Members of the Ahmanson/UCLA Adult Congenital Heart Disease Center advisory board have three main roles: advisors, ambassadors and philanthropic supporters of the center.
