Course Objectives

This one-day virtual symposium is designed to provide participants with relevant, reliable, up-to-date information on the clinical management of HIV-related issues including: management of people with HIV with new or simplified treatment options, or who have demonstrated some degree of resistance to one or more antiretroviral drugs, and the use of antivirals for the prevention of HIV in those at-risk. At the conclusion of this course, participants should be able to:

- Implement the service needs of developing long-acting injectable HIV therapies
- Identify the advantages and disadvantages of currently available PrEP agents.
- Identify the current progress towards HIV cure/ART-free remission.
- Describe challenges of clinical management of COVID-19 infection and risk in the context of HIV infection, and describe the impact of COVID-19 on HIV management

About the Center for Clinical AIDS Research and Education

UCLA has been a leader in AIDS and HIV-related research, education and patient care since 1981 when the nation's first cases of AIDS were identified at the UCLA Medical Center. The UCLA Center for Clinical AIDS Research and Education (CARE Center) was established in 1990 to facilitate clinical research and to integrate current research findings with teaching and patient care

The UCLA CARE Center manages an outpatient clinic dedicated to patients with or at-risk for HIV and maintains an active clinical research program, which evaluates new antiretroviral therapies and preventive interventions, and investigates diseases associated with HIV and the complications of therapy. It is one of the original sites of the Adult AIDS Clinical Trials Group (ACTG) and the AIDS Malignancy Consortium (AMC). An education and outreach program disseminates information on AIDS and HIV infection to healthcare providers and to the community.

The CARE Center is also a primary location for training of medical students and house staff at the David Geffen School of Medicine at UCLA in the optimal care of patients with HIV.

About the Los Angeles Region Pacific AIDS Education Training Center

The Los Angeles Region Pacific AIDS Education and Training Center (LA PAETC) provides direct educational services to a broad range of health providers in Southern California and has developed web-based learning modules available at <https://hivtrainingcdu.remote-learner.net/>. The PAETC also sponsors a free telehealth HIV mentoring program for HIV clinical care teams and individual clinicians that can be found at: <http://paetc.org/contact-us/hiv-learning-network/>.

About the UCLA AIDS Institute

In 1981, UCLA physicians reported the very first cases of what they described as "newly acquired immunodeficiency"—what we now know as AIDS.
