Researcher Spotlight: Dr David Ganz

David Ganz, MD, PhD is a geriatrician and health services researcher based at the VA Greater Los Angeles Healthcare System, UCLA, and RAND. Since joining the UCLA faculty in 2007, he has focused on applied research to improve the quality of care delivered to older adults in routine practice. Dr. Ganz's interest in geriatrics was influenced by growing up near all four of his grandparents, and as a medical student, enjoying the wisdom and poise of older patients. His interest in applied research and quality improvement dates to his time in medical school, when researchers found that even evidence-based treatments for heart disease like aspirin and beta blockers were not being reliably provided to all who could benefit. Since then, although the use of medications recommended for heart disease has improved dramatically, improving the quality of care for geriatric syndromes continues to be a challenge, despite the growing knowledge base in geriatrics.

Over the past 15 years, Dr. Ganz has worked extensively with claims data from Medicare, which provides health insurance to more than 95% of adults age 65 and older in the US, to gain insights into care delivery for older adults with injuries from falls, and more recently to understand the use of medications for opioid use disorder in older adults. He is at the forefront of research to find ways to reliably use data routinely collected by health systems in research. Routinely collected data are inexpensive to obtain. However, repurposing the data for research requires addressing their limitations, like not having the level of detail and accuracy as data explicitly gathered for research studies.

To that end, Dr. Ganz has been using data from the Strategies to Reduce Injuries and Develop Confidence in Elders (STRIDE) study that involved over 5000 adults age 70 and older at increased risk for fall injuries, as a gold standard dataset to assess the usefulness of Medicare claims data. STRIDE study interviewers called patients directly to ask whether they received medical care for injuries from falls and used an extensive adjudication process to verify the falls. Using these verified falls data as the gold standard, Dr. Ganz, along with Dr. David Reuben and colleagues at Yale, Brigham & Women's Hospital, and the University of Michigan, showed that an algorithm to identify fall injuries using Medicare data exclusively was sufficiently accurate for use in research. This opens the door to using Medicare data more routinely in epidemiologic studies, policy analyses, and long-term follow up of clinical trials.
